INTRODUCTION

This guidance is an output of analysis, comparing the indicators specified in <FSC-PRO-60-006b Risk Assessment Framework> against those specified in <FSC-PRO-60-002a FSC National Risk Assessment Framework> and the requirements established in the EU Regulation on Deforestation-free Products (EUDR 2023/1115).¹

The main objective of this analysis was to understand how the indicators of the revised Risk Assessment Framework cover requirements specified under indicators in <<u>FSC-PRO-60-002a FSC National Risk</u> <u>Assessment Framework</u>> and the alignment with EUDR.

RISK ASSESSMENT INDICATORS CROSSWALK

The key changes in the indicators specified in <<u>FSC-PRO-60-006b Risk Assessment Framework</u>> are presented below (see table 1 for further information):

- a) There are 64 indicators in comparison to the 32 indicators of the previous version of the Framework (<<u>FSC-PRO-60-002a FSC National Risk Assessment Framework</u>>).
- b) 57 indicators were part of previous version of the Framework. Minor adjustments have been made to go beyond the legal requirements and assess the sustainability aspects. This implies 89% of the requirements retained to ensure stability of the system.
- c) 5 new indicators included to cover the <<u>FSC-POL-01-007 Policy to Address Conversion</u>> and EUDR.
- d) 2 new indicators included to assess sustainability aspects, aligned with FSC's values focusing on:
 i. minimize the adverse impact on environmental values from development and maintenance of infrastructure, and ii. workers' health and safety.
