The second draft of FSC-STD-30-010, Controlled Forest Management



FOREWORD

FSC-STD-30-010 Controlled Forest Management specifies the requirements applicable at the management unit (MU) level for persons or entities (hereafter referred to as 'The Organization') wishing to demonstrate to a third-party certification body or a business partner that the products supplied from that MU is controlled to avoid the supply of products that are illegally harvested, harvested in violation of traditional and human rights, harvested in MUs in which High Conservation Values are threatened by management activities, harvested in areas in which forests are being converted to plantations or non-forest use or harvested from forests in which genetically modified tress are planted.

The revision of this standard was triggered by the '<u>Strategy for FSC Mix products and Controlled Wood</u>' published in 2019. This strategy aims to reduce reliance of the FSC system on all forms of Controlled Wood and enable FSC-STD-30-010 V3-0 Controlled Forest Management standard as a step towards full forest management certification.

The first draft of the standard was developed in collaboration with and input from a chamber balanced working group and underwent public consultation from mid-October 2022 to mid-December 2022. After detailed analysis of the feedbacks received during the first consultation, the second draft was prepared and shared with the stakeholders for their feedback from 24th of April till 24th of June 2023. This synopsis report serves two purposes. First, to share the analysis of feedback received during the second consultation and compare it with the first one, and second, to show how the feedback influenced the final draft of the standard.

The FSC team and the working group would like to thank all participants of the public consultation.

OUTREACH ACTIVITIES FOR THE 2ND CONSULTATION

Throughout the consultation period, comprehensive range of outreach activities were undertaken to actively engage stakeholders and encourage their participation. These activities included:


- Public webinars: two public webinars were held in English and with simultaneous interpretation Spanish. in which a total of 50 people registered and 40 attended. To accommodate stakeholders from various regions, the webinars were scheduled with a three-week interval and held at different times to suit participants from both the western and eastern hemispheres
- **Communications:** News items about the consultation were shared across multiple platforms, targeting various stakeholder groups. These various platforms were CB Forum, Members' Portal, Newsletters, FSC website (Intranet and public) and MS Team's channels (OneFSC Global).
- Reaching out to CW-FM certificate holders: Specialized outreach was made to invite all CW-FM certificate holders to a tailor-made webinar, designed to provide comprehensive insights into the changes present in the new version and its potential impacts on them. However, due to limited participation, interested certificate holders were offered the opportunity to join the second public generic webinar.

In summary, 40 stakeholders responded through the Consultation Platform, which are described as follows:


BREAKDOWN OF PARTICIPANTS FROM FIRST AND SECOND CONSULTATION

During the second consultation, a total of 40 people provided their feedback in writing, which is slightly less than first consultation, when 51 people responded. This section gives a thorough description of the participants in both consultations.

In the second consultation, 35% of the total participants represented global north while 65% represented global south. Noteworthy that in the first consultation, a more balanced participation was observed. 56% from global south and 44% from global north out of 51 participants.








Similar to first consultation, majority (23) of respondents continued to be classified under the "Other" category encompassing FSC members, consultants, ASI staff and FSC international staff. Subsequently, the second-largest group of respondents belonged to certificate holders' category (14) which remained consistent in both consultations. The rest of respondents were from FSC network partners and certification bodies.



During the second consultation, a notable increased involvement from the FSC members was observed when compared to the first consultation, with 60% of this category whereas in previous consultation the ratio was 52%. Furthermore, unlike previous consultation, participation from both environmental subchambers was gained (Environmental south and Environmental north). Additionally, there was an increased number of participants from social chamber among respondents.





METHODOLOGY

In the second public consultation, five key topics from the standard were surveyed. The topics were presented in a closed question followed by an open question. Respondents were asked to indicate their level of agreement with the proposed topic (i.e., "to what extent do you agree with..."). The respondent could choose their answer from a Likert scale (i.e., "strongly agree, agree, neutral, disagree, strongly disagree"). Following the closed question, an open question was posed, asking the respondent to provide their rationale (i.e., "please briefly explain your rationale") to elaborate their viewpoint.

The FSC team conducted a quantitative analysis to study the closed answers, and a qualitative analysis to study open answers.

In the quantitative analysis, answers were counted per category, and proportions were used to standardise the findings. Findings were also grouped into "positive reception" (Likert scales: strongly agree, agree, and neutral) and "negative reception" (Likert scales: disagree and strongly disagree). Special attention was given into studying the answers with a low "positive reception" through the qualitative analysis.

In the qualitative analysis, key messages were identified across all answers. However, they were more prominent for the 'negative reception' group since it was less likely that respondents provide feedback on topics that they had 'positive reception' towards. Therefore, while reviewing the qualitative analysis it should be noted that they don't represent the viewpoint of all respondents.

These results were carefully considered and analysed by FSC Performance and Standards Unit (PSU) and the chamber balanced working group while preparing the final draft of the standard.

OVERVIEW OF THE STAKEHOLDERS' RECEPTION TO PROPOSED CHANGES

The figures in this section indicate an overall trend of agreement and in the second consultation and provide a comparison between the first consultation and the second one. It is noteworthy that given the number of participants, the responses cannot be seen as fully representative of FSC stakeholders and the membership.

The positive reception of question 1 was 81%. Since this topic was not questioned in the initial consultation, any direct comparison is not feasible.

The question 3 received a notable 94% positive reception (highest agreement among all topics), indicating an improvement in agreement compared to the previous consultation which received 85% agreement.

The positive reception of question 5 was 90% which is a drastic positive change compared to previous consultation with 69% agreement. A substantial level of agreement has been garnered from LA region and economic chambers (from both north and south regions).

3	Please consider including a gender approach, not only promotion of the female gender	Although agreeing with having a holistic gender approach, however the most vulnerable workers in the forestry section are still women. Furthermore, indicator 22.1 already covers this.
4	Requirements are adequate and no change needed.	No change will be made.
5	The requirements pose a high threshold for CW-FM and does not make it an attractive option and suggest dropping it (e.g., FPIC requirements, indicator 28.4).	WG considers that conformity with indicator 46.4 is important in the early stages of the FPIC process and builds the ground for full FM certification with FPIC agreements. Hence, CW WG disagreed dropping this fundamental indicator.

		Proposal to drop indicator 46.4 (IGI 9.4.4) was accepted by the WG, because this is partly covered elsewhere in 30-010 and this will be implemented in full FM/CoC certification.

Question 9 was met with a positive reception of 69%. Notably, this topic obtained the lowest level of agreement during the second consultation.

The five category names do not refer to 'wood' anymore and have been changed to a more generic title. Additionally, the title of the entire standard has been changed accordingly. Lastly, the Working Group also has changed the category names from negative to positive to incentivize the uptake of the standard among forest managers and help to communicate the positive nature of Controlled Forest Management
Category 1	Illegally harvested wood	Forest management and trade that respects and upholds legality	
Category 2	Wood harvested in violation of traditional and human rights	Forest management that respects and upholds customary and human rights, including The ILO Declaration on Fundamental Principles and Rights at Work	
Category 3	Wood harvested in forests in which high conservation values are threatened by management activities	Forest management that maintains or enhances social, cultural, environmental, and high conservation values (HCV)	
Category 4	Wood harvested in forests being converted to plantations or nonforest use	Forest management that prevents deforestation and degradation	
Category 5	Wood from forests in which genetically modified trees are planted	Forest management that is free of Genetically Modified Organisms (GMO)
