1. OBJECTIVE

The objective of the desk testing exercise for the FSC-PRO-60-006 The Development and Revision of FSC Country Requirements">FSC Country Requirements and its addendum FSC-PRO-60-006a The Content and Structure of Forest Stewardship Standard is to evaluate the functionality, effectiveness and feasibility of the draft requirements. This desk testing aims to assess the potential outcomes of implementing the procedure and its addendum. Specifically, the testing will focus on the clarity, feasibility, effectiveness and opportunities for improvement of the draft requirements (see Table 1 below).

Table 1. Description of testing aspects

Testing aspect	Description
A. Assessment of clarity	 Evaluate the clarity and comprehensibility of the procedure and addendum. Identify ambiguities, inconsistencies, or gaps in the draft requirements. Review terminology, definitions, and instructions applicable on the working group (formerly called 'standard developers') to ensure clarity in understanding requirements.
B. Feasibility analysis	 Examine practicality and feasibility of implementing the draft requirements specified in the procedure and addendum and the guidance document. Consider possible challenges & limitations, like, resource constraints, technical limitations, and operational constraints that may impact the implementation. Evaluate the compatibility of the draft requirements with other existing normative requirements followed by working groups.
C. Effectiveness evaluation	 Assess effectiveness of the procedure and addendum in drafting outcome-oriented requirements. Analyse potential impact of draft requirements on resulting FSS that are complete, clear, transparent, and relevant to the given geographical and socio-economic conditions.
D.Identification of improvement opportunities	Identify areas for improvement in the procedure and addendum.

2. TESTING SCOPE

The scope of this desk test encompasses a comprehensive evaluation of the FSC-PRO-60-006 The Development and Revision of FSC Country Requirements>, its addendum FSC-PRO-60-006 The Content and Structure of Forest Stewardship Standard> and FSC-GUI-60-006 Guidance to Develop Outcome Oriented Forest Stewardship Standards>. The guidance is intended to be used by working group and experts in defining requirements for outcome monitoring during development of Forest Stewardship Standards).

3. METHODOLOGY

Hypothesis: The implementation of the draft requirements introduced by FSC-PRO-60-006 and FSC-PRO-60-006a will lead to more efficient and effective processes for the development and revision of FSC country requirements.

The methodology for desk testing of FSC-PRO-60-006 and FSC-PRO-60-006a is designed to ensure a systematic evaluation of the draft requirements. Throughout this testing process, participants are expected to thoroughly review the draft requirements in the procedure, addendum and the guidance, and carefully assess their clarity, feasibility and effectiveness. This will facilitate a comprehensive evaluation and subsequent improvements of the draft requirements.

The methodology encompasses the following steps:

3.1. Preparation phase

- Conduct a thorough review of the procedure and addendum documents to become familiar with the draft requirements, and new concepts like key intended outcomes, conceptual phase, types of consultations, developing indicators for stalled process, etc.
- 2. Review guidance to develop outcome-oriented Forest Stewardship Standard.
- 3. Review intended outcome of the revision process (refer Annex 2) to evaluate if the draft requirements are efficient and effective.
- 4. Use a feasibility analysis checklist (to be provided to selected desk testing participants) aligned with the desk testing objective, focusing on assessing clarity, feasibility, effectiveness and areas for improvements in the procedure and addendum.

3.2. Selection of key areas

- Identify specific sections of procedure that need special focus during the desk testing to make FSC country requirement process efficient, such as phases in each process type, qualification of involved parties - working group members and process lead, identifying crucial sustainability values for developing outcome oriented FSS, conceptual phase, consultation types and number of consultations, requirements for stalled process, etc.
- 2. Similarly, identify important sections in the addendum that need special focus during desk testing and shape FSS in future, this may include requirements on developing indicators of the FSS, additional considerations to be deliberated upon for developing variation of indicators, concept of adopt, adapt or drop IGI or add new indicator, requirements for outcome monitoring, etc.

3.3. Activities to be undertaken by the participants.

- Participants should use feasibility analysis checklist (shared with selected participants) to submit
 the responses to testing questions for each section of the procedure, its addendum and guidance
 document to develop outcome oriented FSS and develop desk testing report (Refer Annex 1 for
 template of Desk testing report).
- 2. Develop prototypes that reflect theoretical implementation of requirements in the procedure and its addendum. This includes:
 - i. <u>Project plan including timelines</u>. Each participant will be allocated a process type for revising a FSC country requirements process (FSS or RA). The participant should develop a project plan comparing the plan with the existing requirements. The purpose of this exercise is to identify the time efficiencies in the draft FSC-PRO-60-006. When developing

- a project plan, the participant should evaluate whether the draft requirements in the FSC-PRO-60-006 are practical, timesaving, and user-friendly. Any gaps and feasibility challenges identified are detailed in the report.
- ii. <u>Develop a mock FSS by developing indicators under at least two Principles from International Generic Indicators FSC-STD-60-004 V2-1 using requirements in 60-006a V2-0 D1-0.</u>

The mock FSS should be developed using, at least, the following scope:

- a. The geographical scope: Country;
- b. The forest type: Natural Forest and Plantations;
- c. The ownership type: Public and community;
- d. The type of management units: includes i) SLIMF, and (ii) MUs with 'high' intensity management operations;
- e. The forest products: Roundwood and NTFPs (Honey and Mushroom); and
- f. At least two outcome-oriented indicators using the FSC-GUI-60-006 Guidance to develop outcome-oriented Forest Stewardship Standard.

The participant should develop indicators using the draft requirements (including rules for developing indicators using concept of adopt, adapt, and drop IGI or add a new indicator, numbering indicators, guidance document for developing outcome oriented FSS, and additional considerations as per relevant FSC normative documents). Developing Annex for respective Principle is not mandatory. Any gaps or feasibility challenges identified is detailed in the report for informed analysis and subsequent improvements in the addendum.

4. DESK TESTING PARTICIPANTS


4.1. Selection of desk testing participants and Eligibility Criteria

The foundation for identifying desk testing participants is the revision process's engagement plan. This plan identified several groups of stakeholders relevant to the revision process (See Figure 1 below).

Among these stakeholders, the **developers of Forest Stewardship Standards (FSS) and Risk Assessments (RA)** stands out as primary users of the draft requirements. Apart from this, members of Advisory Committee can also perform the desk testing with diverse perspectives on the practial implementation of the procedure and its addendum from multiple vantage points. The eligible participants to take part in desk test are:

- Members of Forest Management Communities.
- 2. Individuals or organizations with experience of developing Interim Forest Stewardship Standards and/or Risk Assessments.
- 3. Members of Advisory Committee.

5. EXPECTED OUTPUTS

The expected outputs of the desk testing include:

- 1. A desk testing report, summarizing the key findings and recommendations for improving the procedure and addendum (refer Annex1 for the report template).
- 2. Prototypes (Project plan and mock FSS).
- 3. Completed feasibility analysis checklist (to be provided to the selected participants).

The English version of such communications and materials (including this Terms of Reference) shall prevail. Participants may submit the Desk test report in English, Spanish or French.

11. INTELLECTUAL PROPERTY RIGHTS

Participants warrant that information provided to FSC in the desk test is not subject to the rights of third parties, and in particular, does not infringe copyrights or other intellectual property rights. All rights in any materials which might be provided by or obtained from FSC belong exclusively to their respective

owner(s), and no right, title or interest in or to any of the same is granted, transferred or assigned to the participants.

FSC shall be the sole and original owner of, and shall have sole and exclusive right, title and interest in and to, any work product of the desk test and related proprietary rights (including any materials produced and/or developed based on the information collected in the desk test).

12. TERMINATION OF THE PARTICIPATION

Participants taking part in the Desk test may be terminated or withdrawn at any time by written notice of termination to the other Party (FSC International Center or the Participant) with immediate effect. If participation is terminated or withdrawal, whether by FSC International Center or the participant, data provided by the participant in the desk test prior to the termination or withdrawal will not be used by FSC International Center in the desk test and will not be retained.

The revision of the <FSC-PRO-60-006 The Development and Revision of FSC Country Requirements> and the <FSC-PRO-60-006a Content and Structure of Forest Stewardship Standard> envisages the implementation of a monitoring process against the key intended outcome. This process will evaluate the effectiveness and efficiency of the changes proposed in the FSS-related normative documents. To monitor the impacts of the revised procedure, a set of indicators have been developed to assess the intended outcome of the changes.
